

Cookie Notice

With this Cookie Notice we would like to inform you (hereinafter, the “**User**” or “**Data Subject**”) about how we, at Evyland Limited (hereinafter the “**Company**”), with registered office at Unit A23, Arena Business Centre, Poole, UK (postal code BH177FJ), VAT No. 12835419, which can be contacted at the following email address privacy@evyland.co.uk, are the data controller of personal data collected by means of cookies on our LIV Application (hereinafter the “App”).

1. Cookies

We use cookies which are small files with configuration settings that help us make our App more user-friendly, effective and secure. Cookies are also used to implement certain user functions. In particular, cookies contain packets of information sent by a web server to the visitor/User’s Internet browser and automatically stored by the latter on the device (personal computer, tablet, cell phone, etc.) and automatically sent back to the server each time the site is accessed. The cookie can only be used by the web server that issued it (or by any third parties with whom it was originally shared); this means, for example, that servers managed by third parties cannot read cookies generated by the data controller. The cookie is then re-read and recognized by the App that sent it every time a subsequent connection is made. The cookies used on this Site can be distinguished by virtue of the following criteria:

a) based on who manages cookies:

(i) *first party cookies*: these are cookies installed directly by the Company (or processors acting on its behalf) through the Site.

(ii) *third party cookies*: these are cookies installed through the App by third parties other than the Company and processed by such third-parties for purposes they solely determine.

b) based on the time they remain enabled:

(i) *session cookies*: these cookies store the necessary information during the browsing session and are deleted immediately after the session expires, i.e. when the browser is closed;

(ii) *persistent cookies*: these cookies are stored on the User’s hard disk and the App reads them each time the User visits the App. A persistent cookie has a specific expiry date, after which it will stop working;

c) based on the purpose:

(i) *technical cookies*: these cookies are necessary to allow the User to browse the App and to benefit from its functionalities. If strictly necessary for the use of the App, these cookies do not require the User’s prior consent and cannot be switched off. Without these cookies some services or functions could not be provided and the browsing of the Website would not be easy and functional;

(ii) *analytics cookies*: these cookies are used to obtain statistical information, in an aggregate manner or not, on the number of Users accessing the App and about how the App is used. Where required by the applicable laws, if the User does not consent to these types of cookies, the Company will not be able to improve the App based on information from the User’s visit;

(iii) *profiling cookies*: these cookies are used to trace the User’s profile in order to display advertisements on the Site target on the basis of the User’s interests, tastes and consumption habits. If the User does not consent to these types of cookies, he/she will experience less targeted advertising (but not less advertising overall).

The App uses technical and analytics cookies.

You can choose your browser or the privacy settings of your devices so that you are informed about the setting of cookies and only allow cookies in individual cases. You can also exclude the acceptance of cookies for certain cases or generally and activate the automatic deletion of cookies through privacy

settings as per your device. However, if cookies are deactivated, it is possible that not all functions of our App can be used in full.

2. Cookies currently used on our Website

- Technical cookies

Technical cookies are those that the Company uses for the sole purpose of allowing the User to visit the App and enjoy it. Technical cookies are not used for any purpose other than those mentioned above.

The following technical cookies are currently used on the App:

Cloudflare	Application Security, Application Performance	These cookies allow Cloudflare to maximize network resources, manage traffic, and protect our app from malicious traffic.	Up to 24 hours	Link

Other than as per the general browser settings or privacy settings of the device (as explained above), The User can generally deactivate third party cookies, by accessing the respective privacy information notices and, where relevant, consent forms. However, by deleting or blocking these cookies, the Website (or its functionalities) may not work properly or efficiently.

- Analytics cookies

Analytics cookies are used on the App to collect statistical information, in either aggregate or non-aggregate form, about the number of Users accessing the App and how they visit the App.
